Our goal is to be able to provide our community with the knowledge that they need to understand why we are going to a referendum. There will be a mailing that will come to residents. The mailing will have the ballot language along with some factors of why the district is going to referendum such as: record inflationary increases, insufficient state funding, decrease in enrollment, and growing student needs.





| | The River Ridge School District is placing an operational referendum on the ballot for Tuesday, April 2, 2024. The referendum question asks voter permission to exceed the revenue limit. The revenue limit is a state law which limits the amount of revenue the school district receives to pay operating expenses. |
| Ð | The school district's last operational referendum approved by voters was held February 18, 2014, which allows the school district to exceed the revenue limit by \$350,000 each year. However, the current year's revenue limit, which includes the 2014 referendum, allows the district to receive only \$250,000 more revenue than it allowed eight years ago. |
| River Ridge School District | The school district has experienced significant inflationary increases to its operating expenses over the past few years, which have been primarily supported by federal grants. Those grants are no longer available to the district beginning with the 2024-2025 budget and state revenue limit laws require the school district to ask voters for permission to generate additional revenue through a referendum to exceed the revenue limit. |
| April 2, 2024 Operational | The April 2024 operational referendum asks voters permission to exceed the revenue limit to pay operating expenses beginning with next year's budget in the amount of \$1,250,000, and increasing by \$250,000 a year for the next three budget years (\$1,500,000 and \$1,750,000 and \$2,750,000) and remaining at \$2,000,000) and remaining at \$2,000,000 hereafter ("recurring"). Approval of the operational referendum would give the school board authority to levy taxes in the amounts, and for the budget years, stated in the ballot language. |
| Referendum Information | Voters are not being asked to approve the district's total tax levy for each of the budget years. The vote on the total tax levy occurs at the district's annual meeting each year using the third Friday of September enrollment figures, the certification of aid from the state, and the impact of any legislative changes to the revenue limit law. |



April 2024 Referendum Estimated Tax Impact

- The April 2024 referendum tax impact begins with the December 2024 tax bills.
- The April 2024 referendum ballot question includes four different dollar amounts occurring in four different budget years, with the last amount remaining in tax bills ("recurring" or "ongoing").
- The estimated tax impact is based on the school district revenue limit, state aid formula and property values used for December 2023 tax bills.
- The school district currently receives state aid for operating expenses under a three-tiered formula designed to provide property tax relief.
- Under the current aid formula, the estimated tax impact of the April 2024 referendum is shared with the state providing additional aid to reduce taxes.
- The estimated additional state aid is received the year after the operating expenses occur.

The graph below shows the referendum amounts for each of the next five years broken down by the amount supported by taxpayers and amount supported by state aid based on the current formula at 36%. State aid is not guaranteed and subject to change each year.


