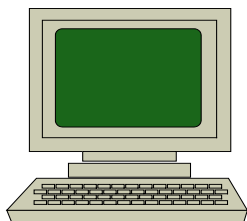


Mark Your Calendar by Jan Block

Student Summer Work by Carol Harris

The River Ridge School District is offering a total of three summer positions. These will be general maintenance assistant and district office assistant positions. The work is performed from June 6 through August 26, 2011. The positions provide approximately 25 to 32 hours per week, and the salary range is \$7.25 - \$8.75 per hour. The salary rate will be adjusted when minimum wage rates change. Selection criteria are as follows:

- Must be a River Ridge High School graduate
- Must be enrolled in a college, university or technical college
- Must be 18 years of age or older
- Must be able to learn to operate the necessary equipment and tools
- Should be trustworthy and have a genuine interest in the job
- Should have dependable transportation to and from the work site

If the District is unable to fill the positions with applicants who meet these criteria, other interested applicants may be considered. Interested candidates should submit resumes and letters of interest to Carol Harris, Business Manager, by May 12, 2011. Please state within the letter which position you are applying for and which university, college or technical college you are enrolled in.

Rescue Squad Visits Elementary School by Jill Faurote

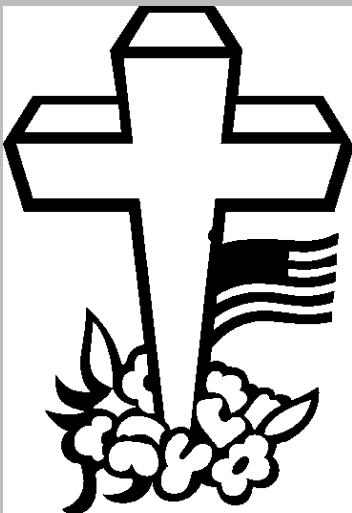

Post-Prom Party by the Post-Prom Committee

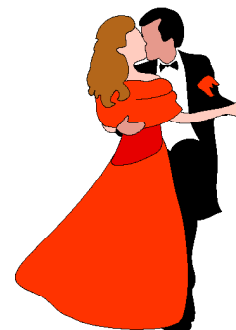

Better Speech and Hearing Month by Sarah Buening

May is Better Speech and Hearing month. The American Speech-Language-Hearing Association (ASHA) started this campaign to help inform families about communication disorders, and to encourage treatment that can help those with difficulty speaking, understanding, or hearing.

A speech or language problem can be seen in many different ways. Some speech and language problems in children include:

- Speech disorders such as articulation problems (saying “wed” instead of “red”), and stuttering
- Language problems such as having a limited vocabulary, using grammar incorrectly, or having poor social skills
- Voice problems such as a persistently hoarse or breathy voice

If you have questions, or if you suspect your child has a speech or language problem, please contact your school’s speech and language pathologist. These professionals can assess and treat speech and language problems. School speech and language pathologists in Wisconsin hold a master’s degree and are certified by the Department of Public Instruction.

Children can also have a hearing loss. This can impact many facets of learning language as they may not hear all of the speech sounds, and/or they may have a difficult time understanding speech. According to the ASHA website, typical signs of a child with hearing loss include:

- The child saying “huh” frequently
- Their responses to questions or directions are inconsistent
- They often misunderstand what was said
- They have unclear speech
- The child often turns up the volume on electronics (TV, radio, etc.)
- A history of ear infections

If you suspect your child has a hearing loss, please contact an audiologist. An audiologist will prevent, assess and treat hearing disorders. Audiologists in Wisconsin hold a doctoral degree. It is important to take proactive steps as soon as possible if you suspect your child has a speech and language problem, and/or a hearing loss.

Regardless if your child has a speech or language deficit or not, it is important to provide a language rich environment. Language is a key component to a child’s devel-

opment. It is beneficial to incorporate language opportunities into daily activities. This can be done in the grocery store by describing a food and having the child guess the food, or help them read the food labels or grocery list. When driving, try to think of rhyming words for an object outside the window or sing songs. Another opportunity for extra language enrichment can be when cooking. Involve your children in the cooking process when appropriate and talk about what you are doing. Finally, reading is one of the most important activities you can do with your child. Children learn many language skills through reading such as vocabulary, grammar and sequencing. In honor of Better Speech and Hearing Month, try to involve your children in more language-rich activities and enjoy building their speech and language skills. More Fruits

To get the most nutrition out of your calories, choose foods packed with vitamins, minerals, fiber and other nutrients—and lower in calories. Pick fruits, vegetables and fat-free or low-fat dairy more often. Be aware of portion sizes. Even low-calorie foods can add up when portions are larger than you need.

Ways to Enjoy More Fruits

- Heat leftover whole-grain rice with chopped apple, nuts and cinnamon.
- Make a habit of adding fruit to your morning oatmeal, read-to-eat cereal, yogurt or toaster waffle.
- Puree berries, apples, peaches or pears for a thick, sweet sauce on grilled or broiled seafood or poultry, or on pancakes, French toast or waffles.
- Add pizzazz to sandwiches with sliced pineapple or apple as fillings.
- Blend up a breakfast smoothie made with low-fat milk, a frozen fruit and a banana.
- Garnish cottage cheese with apple slices and a sprinkle of cinnamon.
- Keep in-season fruits cleaned and ready to eat in your refrigerator.
- Add color to green salads with mandarin oranges.

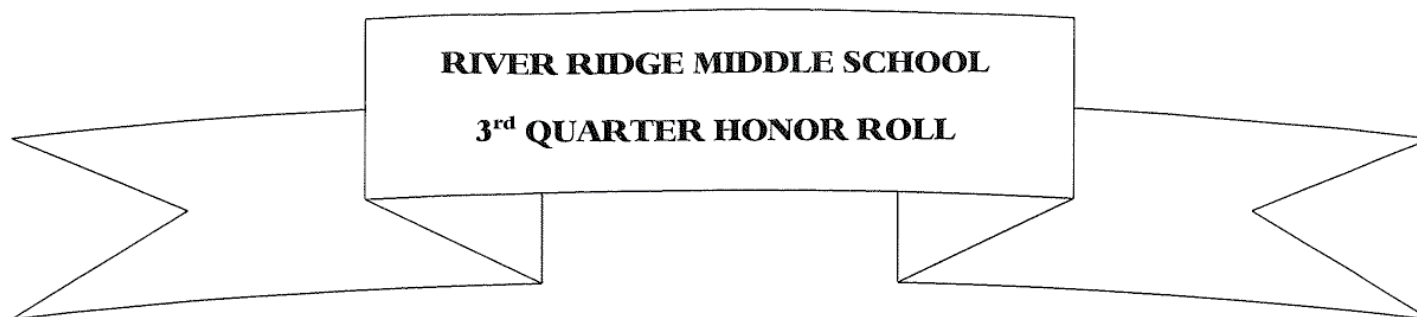
